MINUTES OF A MEETING OF BRADWALL PARISH COUNCIL

2. MINUTES OF LAST MEETING

The minutes of the meeting held on 29th January 2015, which have been circulated, were approved and signed as a correct record. Proposed Cllr. G. Gnyp, Seconded Cllr. G. Williams.

3. MATTERS FOR REPORT

a) Highways.

The water leak on Wood Lane has been reported to both Cheshire East and United Utilities. UU have visited and confirmed that it is not a leak from their supply because the water is not chlorinated and there are no fresh water pipes in this area! John Tickle at Cheshire East Highways has responded by email and says that a works order has now been raised for a contractor to do the work/repair.

The Clerk has discussed the narrow bridge over Sanderson's Brook (known as Zulu Bridge) with Stuart Bateman and is planning to meet him on site.

b) Boundary Signs.

CE has responded that boundary signs cost in the region of £500 each for full supply and installation. Requested a cost for installation only but this was not forthcoming. It was agreed to await the outcome of another parish council's boundary sign replacement exercise (Hassall) to see the full costs and possible alternative suppliers that could be used.

c) Broadband.

The existing poor speed of broadband connection in the parish was discussed and Richard Smedley provided some further technical information. The cost of installing a fibre optic cable to business premises is £500 and then there are additional monthly charges of approximately £50. It may be possible to install a fibre optic cable to a suitable location and then share via a WiFi service to residents. Grants to support such installation can be applied for. It was agreed to investigate the possibility further but the Clerk will also find out if BT have any infrastructure improvement plans for the area.

4. FINANCIAL MATTERS

5. PLANNING MATTERS

<u>14/4952C Bradwall House</u> – Conversion of barns to games room, gym and stores. No decision.

<u>14/5757 Hollins Green Farm</u> – to demolish farm buildings and build new office. Permission with conditions granted 29th January 2015.

<u>14/0451C Proposed Development of 4 dwellings at Hollins Green.</u>
<u>Appeal Ref. APP/R0660/A/14/2218480</u>. Appeal dismissed on 12th January 2015. 14/5780C the re-submission of the above was also refused on 13th January 2015.

<u>14/5884C Beech Tree Farm</u> – Conversion of farm buildings to dwellings. Refused 27th February 2015.

14/5721C & 14/5726C Gypsy and Traveller Transit Site, Cledford Lane – Application for 9 transit and 1 permanent warden pitch and to convert the barns to toilet and washing facilities and an office. A letter of objection was submitted. The current date for consideration of this application by the planning committee is 22nd April.

<u>Former Ideal Standard Site, Cledford Lane, Demolition works</u> – The Clerk and Cllr. Roden had separately attended an information event at Middlewich Civic Centre. Possible traffic problems are the major concern of this council.
