<u>Brereton Playgroup</u> – are building a replacement building. After studying the submitted report and costings it was resolved to make a grant of £750. It was also agreed to consider a further grant to this group in the next financial year, if they still require funds.

<u>Sandbach Striders Running Club</u> – are holding a 10k race around Bradwall using the village hall as the base. It was agreed to make a donation of £50.
